

Definition

Criminal Justice is a system of institutions and practices aimed at upholding social order, deterring, investigating and mitigating crime, and/or sanctioning those who violate laws with criminal penalties or rehabilitation efforts. In the U.S. there are numerous criminal justice systems that differ by jurisdiction.ⁱ

Numbers at a Glance

- In the US, blacks are 3.5 times more likely to be in jail than whites, in NH 5 times more likelyⁱⁱⁱ
- NH ranks 5th in the US for referring students to law enforcement from schools. Black students are nearly twice as likely as white students to be referred.^{iv}



Jail data are averages from four Hillsborough County jail censuses, taken at six-month intervals on 9/1/2014, 3/21/2015, 9/1/2015 and 3/21/2016. The number of people incarcerated for drug offenses ranges from 52 to 80 each day.

Pretrial detention can have devastating consequences including job loss, eviction, or loss of child custody. Jail data from four Hillsborough County jail censuses (between 9/1/2014 to 3/21/16) show that people of color are disproportionately held in jail pre-trial.

Case Example

Across the United States, young people of color are more likely to have contact with the juvenile justice system than white youth; this is known as Disproportionate Minority Contact (DMC). In NH, the rate of arrests of black/African American youth was more than three times higher than that for white non-Hispanic youth in 2013.

To address this problem, NH has a DMC Coordinator working to improve the relationships between youth and law enforcement. More than 275 of NH's police officers have participated in Effective Police Interactions with Youth, a training specifically designed to help officers understand youth development and juvenile behavior, as well as the increasing diversity of New Hampshire. In addition, NH's DMC Coordinator designed a training specifically for youth that "mirrors" the training for officers. Called The Mirror Project, this training helps youth better understand what they can expect should they find themselves in an encounter with law enforcement. More than 3,000 juveniles in Manchester and Nashua have participated in The Mirror Project.
