Definition


Education is the process of teaching or learningⁱ and is commonly divided formally into stages as early learning, primary school, secondary school, and college, university or apprenticeship. Education can take place in informal or formal settingsⁱⁱ and can occur across the lifespan.

Numbers at a Glance

Reading at grade level, consistent attendance, and graduating are predictors of educational success:

- 31% of Hispanic and 26% of black students were proficient in math by 4th grade compared to 57% of white students.^{iv}
- Hispanic students are 3 times as likely to miss school because they feel unsafe than white students; black students are almost twice as likely.
- 20.2%, 21.8% and 13.6% of Hispanic, American Indian, and black students respectively lack a high school degree compared to 8.9% white students. vi

Case Example

Young Organizers Unitedvii (Y.O.U.) based in Manchester, NH, is a group of high school aged youth from various backgrounds who are dedicated to strengthening multi-issue and multi-racial coalitions designed to overcome ethnically and racially disparate school treatment. Student voice is crucial in shaping and implementing educational policies throughout the Manchester School District and beyond. Y.O.U. works to provide information, skills, and leadership training to help empower youth through student-centered learning.

In 2017, Y.O.U. launched a summer program – an intensive eight-week experience featuring two cohorts of programming: the Advocacy Team and the Journalism Team. Members of the Advocacy Team learned about community and youth organizing while working on two real-life campaigns: Student Representation within the Manchester School District and the Office of Civil Rights Resolution Agreement Campaign. The Journalism Team worked to develop writing skills for digital and print media, and gained an understanding of the roles and responsibilities of media in the 21st century through a social justice, grassroots community organizing, and advocacy lens.
