Environmental Justice in New Hampshire

What is Environmental Justice?

Environmental Justice (EJ) is the **fair treatment** and meaningful involvement of all people, regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies.

Everyone has the right to a healthy environment. You should be able to expect the same healthy environment as any other neighborhood or community. Your community should be involved in decisions that affect your community's health and environment.

Low-income communities, communities of color, and residents with limited English proficiency often suffer the "first and worst" effects of environmental harm, including exposure to severe heat, lead paint in homes, and air and water pollution.



Many communities lack access to resources to build resilience and improve quality of life. These resources include green spaces, access to healthcare and transportation, and cooling spaces.

Recent EJ Case Examples

East Hollis, Nashua Defeated Proposal for Asphalt Plant



In 2022, activists rallied against a proposal to build an asphalt plant in Nashua. The plant would have been built in an area that is home to many immigrants and people of color, and would have significantly increased air and noise pollution, and commercial traffic. Community activism and legal testimony led to the proposal's rejection in July 2024.



Manchester Urban Forestry Program



In 2024, the City of Manchester launched a bold Tree Equity Program. Trees will be planted and green spaces created to address extreme heat and environmental inequities. The Manchester Environmental Justice Advisory Group identified issues of tree inequities and heat islands and mobilized support for the Program. Members of the Advisory Group will join the Urban Forestry Committee to guide planning and implementation of the Tree Equity Program, and a "Tree Ambassador" program will provide workforce development opportunities to equip community members with urban forestry skills to ensure program sustainability.



environmental contaminants.

The North Country has been fighting NH's ongoing waste crisis for decades. The region houses major landfills, though most of the waste comes from out-of-state. In 2023, Casella Waste Systems proposed a new landfill in Dalton. The landfill would be 70 acres and receive 1,800 tons of waste every day for 18 years. The current battle against this proposal is an important opportunity for residents to voice their concerns and protect the communities most affected by
